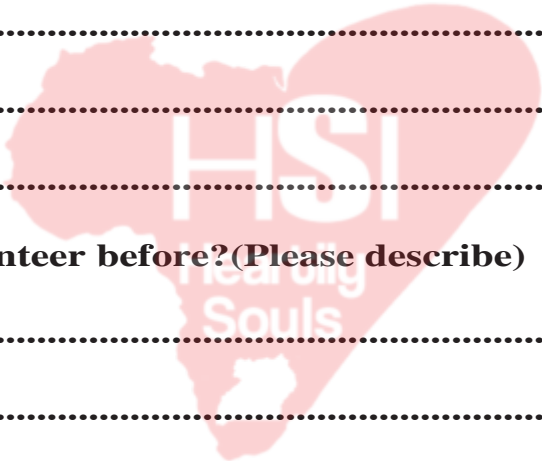

## **Volunteer Contract**

This Volunteer Contract ("Contract") is entered into between Heartily Souls Charity Organization ("Organization") and \_\_\_\_\_ ("Volunteer") on \_\_\_\_\_ (Date)

1. Volunteer's Responsibilities: 1.1 The Volunteer agrees to provide voluntary services to the Organization as specified in the Volunteer's role and position. 1.2 The Volunteer shall commit to dedicating [number of hours per week/month] for the duration of [start date] to [end date] (if applicable), or an ongoing basis until either party terminates this agreement. 1.3 The Volunteer acknowledges that they have read, understood, and agreed to abide by the Organization's policies, procedures, and code of conduct.
2. Participation Fee: 2.1 The Volunteer agrees to pay a participation fee of \$\_\_\_\_ (USD) to support the activities and initiatives of the Organization. This fee is non-refundable and shall be paid by [payment method] to be communicated upon reply on due date. 2.2 The Organization agrees to use the participation fee solely for the benefit of the Organization's charitable purposes.
3. Confidentiality: 3.1 The Volunteer shall maintain the confidentiality of any privileged or sensitive information obtained during their volunteering activities and shall not disclose such information without prior written consent from the Organization.
4. Liability and Insurance: 4.1 The Volunteer understands and acknowledges that they are responsible for their actions and assume all risks associated with their participation in the Organization's activities. 4.2 The Volunteer agrees to release and hold harmless the Organization, its officers, directors, employees, and agents from any claims, damages, or liabilities arising out of their volunteer activities, except for gross negligence or intentional misconduct.

5. Termination: 5.1 Either party may terminate this Contract at any time by providing written notice to the other party. 5.2 The Volunteer understands that termination of this Contract may result in the forfeiture of their participation fee, unless otherwise agreed upon in writing by both parties.
6. Governing Law: 6.1 This Contract shall be governed by and construed in accordance with the laws of [Jurisdiction], without regard to its conflict of laws principles.
7. Entire Agreement: 7.1 This Contract constitutes the entire agreement between the Organization and the Volunteer and supersedes all prior oral or written agreements, understandings, or representations.
